Kelli Kelnar: So first off with the FAFSA graduation law. This law was passed last year, but it goes into effect for this school year coming up, that seniors at any Oklahoma public high schools must complete a FAFSA in order to graduate.

Kelli Kelnar: The State Department of Education has put some resources on their website, which you can see here, and there are opportunities if students or families need to opt out of completing the FAFSA. So we'll go over that a little bit later.

Kelli Kelnar: but we learned last week the Department of Education, said the new FAFSA, the 2025-26 FAFSA will not be released until December 1, 2024.

Kelli Kelnar: left 64 million dollars in Pell Grants on the table, meaning they just did not apply for that money, so hopefully with the FAFSA graduation requirement, we'll have more students applying and they will realize that there is money out there to help them pay for college or career tech, or wherever they decide to go.

Kelli Kelnar: But again, this is for the senior class of 2025, meaning they will complete the 2025-26 FAFSA.

And then families that are filling out the FAFSA, the 2025-26 FAFSA will be using their 2023 tax information. So all the years are a little crazy, but we just want to make sure that you understand

It will not be sent to the State Department of Education. You won't turn it in anywhere. You will just keep it at your school

Kelli Kelnar: You can also collect emails that the student will receive after they've submitted a FAFSA. They should get a confirmation email. Do not submit a new list, because a new list will throw things off. So if you tell us which students to add or delete, send that directly to me, and we'll be able to do that for you.

Kelli Kelnar: for some other reason, you won't see that. Only the colleges will see the details of the information that's missing from a FAFSA. But at least that way you'll know which of your students have started the process, if they've submitted the form, but haven't completed it. Kelli Kelnar: If the student does not show parent information, the only thing they could qualify for is an unsubsidized student loan, which would not be enough to cover their tuition, and the unsubsidized loans are not the most favorable, because interest on those loans starts to accrue as soon as the student is in college or career tech. So we want them to try to get free money if possible.

Kelli Kelnar: If the parent doesn't have a Social Security number that should not be a deterrent, they can still complete a FAFSA. And now every every student must complete what's called a StudentAid.gov Account.
